The club enjoyed a potluck lunch and our guest speaker's presentation from 12:00 pm - 1:30 pm.

GUEST SPEAKER

Verla Brown introduced our guest speaker, Michelle Groenevelt. Michelle has earned the title of Certified Planner from the American Institute of Certified Planners and is the Community and Economic Development Director at the City of McCall. She manages the department responsible for planning, building, grant writing, geographic information systems, and economic development. Michelle sits on the Board of Directors for Idaho Smart Growth, Payette Land Trust, and on the Planning Committee for the Mountain and Resort Town Planners Summit. She is also the business owner of the retail boutique, Mountain Monkey Business.

Michelle presented an overview of the Community Economic Development in McCall, "McCall in Motion". "McCall in Motion" outlines the community's vision and goals based on trends and public processes, provides policy guidance for future land use and transportation developments, and recommends implementation strategies and priorities. The objectives are to reaffirm the values of McCall residents and stakeholders and their vision for the future, and to focus the application of polices and tools from past plans. They have reached out to the community with 40 plus outreach opportunities, 10 questionnaires, 650 respondents and over 3000 process participants. The key goals are to enhance public access to lakes and rivers; connect and expand pathways, trails and sidewalks; provide a balanced year-round economy; promote green development and stewardship; protect views, public space and the environment; provide a range of housing choices; create unique places; develop streets that are comfortable for all users; create civic and cultural activities; develop and revise tools to implement the vision; and support downtown and urban growth boundary and conservation easements.

Some specific goals are to lay the infrastructure for fiber optics, extend sidewalks from downtown McCall to Deinhard, provide a new transit center near City Hall, manage parking shortages and increase affordable housing. Michelle noted that only 28% of home owners in McCall are year round residents. For more information visit the City of McCall website.

Gail also read a thank you note from McCall Digest and Payette Children's Rain Forest. McCall Digest awarded prizes to 5 participants and refunded PLPC the balance of the grant left unused, in the amount of \$250.29.

TREASURER'S REPORT: Treone Cooley, Club Treasurer, reported on the prior Fiscal Year, June 1, 2018 – May 31, 2019 financials and the June 1, 2019 – May 31, 2020 budget, which were emailed to members prior to the meeting. The financials were audited by Rita Bolli, Marge Krahn, and Cheryl Meinzer on July 11, 2019. The ending balance was reported by Treone as \$49,654. Linda Hallock made a motion to approve the Fiscal Year, June 1, 2018 – May 31, 2019 financials and the June 1, 2019 – May 31, 2020 budget as presented. Kathy Menten seconded the motion, and the motion was passed unanimously. Treone thanked Camilla Switzer for help in maintaining the club memberships on google and Tracy Faaborg for help in maintaining the club website.

FUNDRAISING REPORT: Linda Hallock, Fundraising Chair, reported a net profit of \$3,297 from our June Fashion Show Fundraiser.
